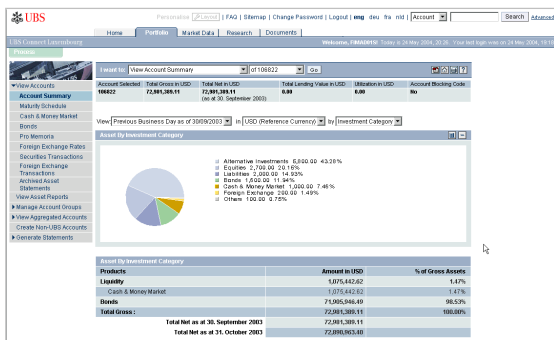


Fig 1: UBS Connect Belgium
