## UBS KeyClub: membership conditions

### General conditions

Membership of UBS KeyClub entails no obligation. Registration is normally made by the client, and UBS may reject an application without stating any reason. UBS reserves the right at any time and without prior notice to amend the membership conditions, the basis for calculating bonus points, the range of qualifying products and services and the selection of partners and their products or services included in the programme, as well as to terminate UBS KeyClub itself.

### Collecting and redeeming bonus points

#### Collecting points

Members receive bonus points corresponding to the amount of their assets under management by UBS, their use of UBS credit cards and their loyalty to UBS KeyClub. The number of bonus points awarded is calculated using a special system. The conditions which currently apply for collecting and cashing in bonus points are published in the UBS KeyClub periodicals and on the Internet. UBS KeyClub automatically collates all registered accounts/cards held by the same person and sends the statement of bonus points to a single address. Where special mailing instructions have been issued, UBS reserves the right to withhold statements.

Special rules for collecting points apply to holders of a UBS Generation, UBS Campus or UBS Young Professional offering. These special rules cease to apply when the UBS Generation, UBS Campus or UBS Young Professional offering is terminated. If the UBS Generation, UBS Campus or UBS Young Professional offering is converted into a UBS personal account or UBS savings account, the standard points system is automatically applied without any prior notification. The above otherwise applies.

#### Bonus points

Members are sent point cheques by post at regular intervals, in each case for a minimum of 25 points (or a minimum of five points for holders of a UBS personal account Generation and holders of a UBS personal account Campus). Objections to the calculation of points must be received by UBS within 30 days of the client's receipt of his or her statement. Bonus points expire on

the date printed on the cheque and cannot be converted into cheques with a later date. They may only be redeemed against offers available at that time (as indicated in the current UBS KeyClub periodicals and on the UBS KeyClub homepage). Bonus point cheques cannot be exchanged for cash and will not be replaced if lost. Unpaid bonus points (fewer than 25 points or five points in the case of holders of a UBS personal account Generation and holders of a UBS personal account Campus) will be carried forward and will expire when you leave or are excluded from KeyClub.

#### Redeeming bonus points

Point cheques allow members to use the products and services of UBS and its external partners. Entitlement to the products and services offered may be subject to special conditions and restrictions. Some of the products and services on offer may be subject to limited availability, and the range may be changed at any time. The respective providers are the member's exclusive contracting partner in respect of the products or services acquired. UBS accepts no liability for products and services acquired with bonus point cheques. All point cheques are transferable.

#### Other conditions

Members may at any time submit their resignation from UBS KeyClub to UBS in writing. UBS may also exclude members from KeyClub or bar them from acquiring further points without stating any reason. UBS may furthermore cancel or curtail a member's right to redeem points if he or she abuses his or her privileges, or is suspected to have done so. Should UBS KeyClub be dissolved, UBS will determine the procedure for dealing with any bonus points collected or bonus point cheques issued at the time of the dissolution. By joining UBS KeyClub and informing it of their UBS Credit Card numbers, members simultaneously authorize UBS to access detailed client and sales data in relation to their UBS Credit Cards and to store such data, together with any other information required to calculate their bonus points, in electronic form. Members acknowledge and agree that the information provided to UBS KeyClub upon registration may be used for marketing purposes within the UBS Group.

In all other respects, the UBS General Terms and Conditions apply.
