This product is intended for use as a **Standalone Solution** for a consumer who is seeking **Income Distribution and Capital Growth** and has a **Medium - High risk and return** profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with **at least a 5 year investment timeframe** and who is unlikely to need to withdraw their money on **less than one week's** notice.
