### Fund description

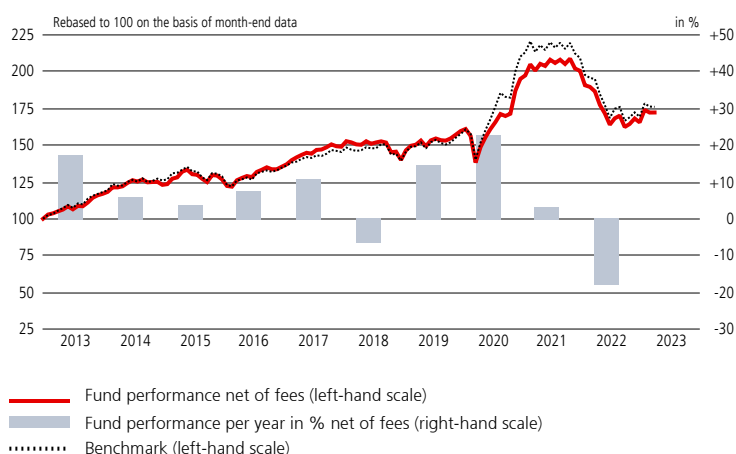
- The actively managed fund invests worldwide in convertible bonds.
