- Foreign currencies are largely hedged versus the reference currency.
- The portfolio manager is not tied to the benchmark in terms of investment selection or weight.
- The exchange rate risk between EUR and CHF is largely hedged.

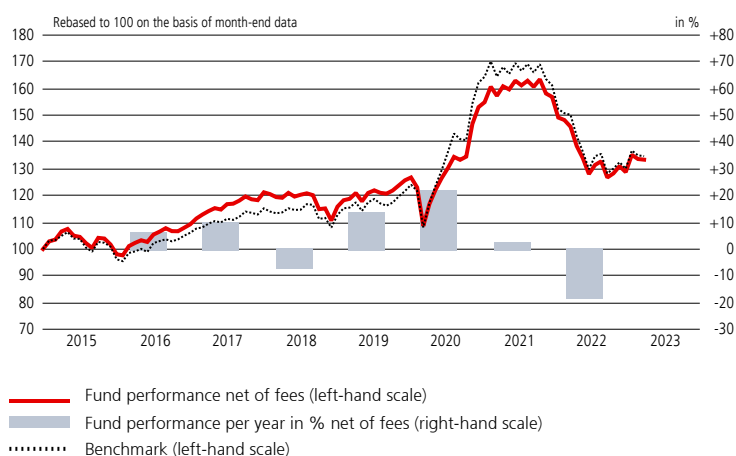
