

## **Notice for Subdivision 12-H of Schedule 1 to the Taxation Administration Act 1953**

### **For the quarterly distribution period ended: 30 September 2016 (year of income ending 30 June 2017)**

**UBS IQ Morningstar Australia Dividend Yield ETF** is a Managed Investment Trust for the purposes of subdivision 12-H of Schedule 1 of the Taxation Administration Act 1953 ("TAA 1953").
