

Notice for Subdivision 12-H of Schedule 1 to the Taxation Administration Act 1953

For the half-yearly distribution period ended: 30 June 2016 (year of income ending 30 June 2016)

UBS IQ Morningstar Australia Quality ETF is a Managed Investment Trust for the purposes of subdivision 12-H of Schedule 1 of the Taxation Administration Act 1953 ("TAA 1953").
