

## Notice for Subdivision 12-H of Schedule 1 to the Taxation Administration Act 1953

### For the annually distribution period ended: 30 June 2016 (year of income ending 30 June 2016)

**UBS IQ MSCI USA Ethical ETF** is a Managed Investment Trust for the purposes of subdivision 12-H of Schedule 1 of the Taxation Administration Act 1953 ("TAA 1953").

The following "fund payment" information is provided as a Notice, in accordance with subsection 12-395 of Schedule 1 of the TAA 1953.
