Dear Shareholder

We are writing to you as a Shareholder to inform you that pursuant to an internal structural re-organisation at UBS, UBS AG under Swiss merger law will transfer its contractual obligations to a new entity, UBS Asset Management Switzerland AG. Subject to regulatory approval, it is expected that, effective on or around 17 June 2019, UBS Asset Management Switzerland AG will replace UBS AG as distributor of the Company.

The rationale for this change is that due to the evolving worldwide regulatory requirements affecting the entire industry, UBS AG has made several changes in recent years to its legal structure to comply with too-big-to-fail legislation. As part of these changes, the Swiss asset management business, currently in UBS AG, will be transferred to UBS Asset Management Switzerland AG, a new Swiss legal entity which is a member of the UBS Group. UBS Asset Management Switzerland AG will take over the existing business relationships from UBS AG by way of a transfer of assets and liabilities pursuant to the Swiss Merger Act which allows for a transfer by operation of law. This change is not expected to cause substantial changes to existing operational processes or how UBS serves clients.

The prospectus of the Company and the supplements for the relevant Funds will be amended to reflect this change and updated versions will be made available to Shareholders at the registered office of the Company.

Capitalised terms used herein, unless otherwise defined, shall have the same meaning as given to them in the prospectus of the Company.
