Dear Shareholder

We are writing to you as a Shareholder to inform you that pursuant to the terms of the prospectus of the Company (the "**Prospectus**") and the supplement for each Fund (each a "**Supplement**" and together, the "**Supplements**"), the Directors have exercised their discretion to amend the definition of "Business Day" as set out in the Prospectus and the Supplements, with effect from 22 June 2020, as follows:

Prospectus:

The Prospectus currently contains the following definition of "Business Day":

"unless otherwise specified in a Relevant Supplement, a day on which markets and commercial banks are open in Ireland, and such other day or days as the Directors may determine and notify in advance to Shareholders;"

This definition shall be deleted and replaced with the following:

"unless otherwise specified in a Relevant Supplement each normal bank business day in Ireland, inclusive of all public and/or bank holidays other than the following – New Year's Day, Good Friday, Easter Monday, Christmas Day and St. Stephen's Day, and such other day or days as the Directors may determine and notify in advance to Shareholders;"

Supplements:

The Supplements each currently contain the following definition of "Business Day":

"Each normal bank business day in Ireland (i.e. each day on which the banks are open during normal business hours) and days on which the Primary Stock Exchange, on which the constituents of the Index are traded, is open for trading, except individual, non-statutory rest days and days on which the Primary Stock Exchange in the main countries in which the Fund invests are closed, or on which 50% or more of the investments of the Fund cannot be adequately valued and/or such other day or days as the Directors and/or the Manager may determine and notify in advance to Shareholders."

This definition shall be deleted and replaced with the following:

"Each normal bank business day in Ireland, inclusive of all public and/or bank holidays other than the following – New Year's Day, Good Friday, Easter Monday, Christmas Day and St. Stephen's Day – and days on which the Primary Stock Exchange, on which the constituents of the Index are traded, is open for trading, except individual, non-statutory rest days and days on which the Primary Stock Exchange in the main countries in which the Fund invests are closed, or on which 50% or more of the investments of the Fund cannot be adequately valued and/or such other day or days as the Directors and/or the Manager may determine and notify in advance to Shareholders."

Shareholders wishing to subscribe on any Business Day may do so in accordance with the terms of the Prospectus and the Supplement for the relevant Fund. Should you wish to subscribe on any Business Day please liaise directly with your normal contact at the Administrator.

Capitalised terms used herein, unless otherwise defined, shall have the same meaning as given to them in the Prospectus.
