Sub-Fund and Index Replacement

The board of directors of the Fund and of the Management Company (together, the "**Boards**") hereby inform the shareholders of the Sub-Fund that the underlying index, tracked by the Sub-Fund, will be replaced by a new index focusing more on companies with low exposure to carbon emissions. In the interest of shareholders, the Fund will execute the abovementioned index replacement. Subsequently, the name of the Sub-Fund will be changed accordingly.

As a result of the aforementioned replacement, the name of the Sub-Fund and its index will be amended as follows:
