*Capitalised terms not otherwise defined in this letter have the meaning given to them in the prospectus of the Company and the supplement for the Fund each dated 1 December 2022 (together, the “Prospectus”).*

Dear Shareholder

We are writing to inform you about an extension to the temporary reduction in the Flat Fee charged to share classes of the Fund, as described in the Appendix hereto.

The reduced fees described in the Appendix have applied since 28 February 2022. The reduced fees were due to expire and return to the “Existing Fee” level disclosed in the Appendix on 28 February 2023. However it has been determined that the reduced fee will continue to apply for the period from 28 February 2023 to 31 July 2023.

For the avoidance of doubt, the Flat Fee will return to the “Existing Fee” level described in the Appendix from 1 August 2023, subject to any notification from the Board otherwise.

This notice is for information purposes only. You are not required to take any action. Due to the temporary nature of the reduction, the supplements of the Fund will not be amended.
