UBS MTF would like to announce an update to the UBS MTF Stock Universe published on our server and on our website under <https://www.ubs.com/global/en/investment-bank/multilateral-trading-facility/reference-data.html>.

In order to facilitate the use of the Periodic Auction order book, our daily Stock Universe file will include additional values for each instrument: Periodic Auction Maximum Duration, Tick Size Rule and Supported Services. These additional values will appear in the UBS MTF Stock Universe file from **Monday 11 June 2018**.

1. Overview

The UBS MTF Stock Universe is published each morning at 06:00 UK Time, Monday to Friday. Where necessary, revisions may be made until 07:00.

1.2. SFTP (deprecated)

SFTP login is via password, or SSH public key provided by the user.

To log in to the site, the source IP addresses which will be used to access it must also be provided. These can be provided via e-mail to UBS MTF Market Supervision at ubs_mtf@ubs.com.

2. File Format

The file is an ASCII, CSV-formatted list of records, terminated in UNIX style (linefeed only), consisting of one Header Record, zero or more Data Records, and one Footer Record. The first field indicates the record type; (H)header, (D)ata, or (F)ooter.

2.1. Header Record

Contains a list of data field names; currently the following:

H,UMTF,ISIN,DESCRIPTION,CCY,LISTING,MIC,MINIMUM_LIS,CAPPED,CAP_END_DATE,PERIODIC_AUCTION_MAX_DURATION,TICKRULEID,SUPPORTED_SERVICES

UBS MTF may add additional columns to this file in future, however existing columns will not be removed or reordered without prior communication via market notice.

It is strongly recommended that users of this file be prepared to ignore new columns which are added over time.

2.2. Data records

Contains individual instrument definitions.

For all EEA Markets, UBS MTF uses the ESMA Tick Size table published in RTS 11 and for Swiss instruments UBS MTF uses the Tick Size values published by the Primary Market.

Each XUBS Rule ID will display the relevant tick size for the price range for the instruments.
