

FACTS WHAT DO WE DO WITH YOUR PERSONAL INFORMATION?

Why? Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What? The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Account and application information, account balances and transaction history
- Assets, investment experience and risk tolerance

When you are *no longer* our customer, we continue to share your information as described in this notice.

How? All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information - the reasons we choose to share, and whether you can limit this sharing.

What we do	
How do we protect your personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We restrict access to your personal information to those employees and agents who need to know that information to provide products or services to you.
How do we collect your personal information?	<p>We collect your personal information, for example, when</p> <ul style="list-style-type: none"> • you open an account • seek advice about your investments • direct us to buy or sell securities • give us your contact information or your income information <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can't you limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> • sharing for affiliates' everyday business purposes—information about your creditworthiness • affiliates from using your information to market to you • sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>
Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • <i>Our affiliates include companies with a Credit Suisse, DLJ or UBS name and other financial companies such as Select Portfolio Servicing, Inc.</i>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • <i>Nonaffiliates we share with may include clearing brokers, custodians, accountants, auditors and attorneys.</i>
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> • <i>Our joint marketing partners may include insurance companies and investment managers. We will get your consent prior to disclosing your personal information under a joint marketing agreement.</i>
Other important information	
<p>We reserve the right to disclose information about you to federal, state, and international governmental entities, regulatory authorities, and self-regulatory organizations in connection with court orders or other similar legal process and as otherwise required by applicable federal, state, or foreign law.</p>
