Purpose

UBS's Supplier Code of Conduct sets out our expectations for our suppliers to support our sustainability priorities, embody positive environmental, social and governance practices in their operations and supply chain and operate according to the highest standards of business conduct, integrity and adherence to the law.

All UBS suppliers are expected to comply with this code of conduct and require their sub-contractors and suppliers to meet the relevant standards as well.

Updates

This Supplier Code will be periodically updated and revised to reflect changes in laws and regulations, as well as UBS's policies and standards. The most current version is available online at <https://www.ubs.com/global/en/our-firm/suppliers/supplier-code-of-conduct.html> (the "UBS Supplier Website") and, unless stated otherwise, will be effective when posted.

We expect our Suppliers to keep informed as to any changes to this code of conduct and to visit the UBS Supplier Website regularly to keep themselves up to date. Compliance with this code of conduct shall be each of our Supplier's responsibility.

Acceptance and confirmation of this Supplier Code of Conduct

We expect our Suppliers to accept and confirm this Supplier Code of Conduct followed by a UBS onboarding procedure before participating in any sourcing activities.

Violations

Any violation of this Supplier Code of Conduct should be notified to UBS immediately.

As a supplier, if you or your staff identify or suspect any misconduct or behavior that may have an actual or potential negative environmental or social impact on stakeholders within our value chain, including workers and communities, you should report this via our Report Misconduct page at <https://www.ubs.com/global/en/contact/ubs-staff-misconduct.html>

Concerns should be raised in good faith, and without fear of reprisal. Examples of these environmental and social issues include, but are not limited to:

- Pollution or nature degradation
- Treatment of hazardous waste
- Working conditions
- Modern slavery, Forced labor or Human rights
- Unethical behavior

Responsible Supply Chain Management

We embed environmental, social and governance (ESG) standards into our sourcing and procurement activities. Our firm-wide Responsible Supply Chain Management (RSCM) framework is based on identifying, assessing and monitoring vendor practices in the areas of human and labor rights, the environment, nature, health and safety, and anticorruption.
