Introduction

These reports with Top 5 execution venues and Top 5 brokers refer to the obligations set out in art. 27.6 of Directive 2014/65/EU (“MiFID II”) and art. 3 of Commission Delegated Regulation (EU) 2017/576 (“RTS 28”), and outline the identity of the main execution venues, in terms of volume, where Credit Suisse AG and Credit Suisse (Switzerland) Ltd. (hereafter “Credit Suisse”) have actively executed clients’ orders, and the main brokers, in terms of volume, where Credit Suisse has routed its clients’ orders for further execution both for retail and professional clients, in the preceding year.

This report is intended to cover the period from 1/1/2020 to 31/12/2020 inclusive. As outlined in ESMA’s Q&A on MiFID II and MiFIR investor protection topics, certain aspects of the RTS 28 requirements are tied to new provisions from MiFID II or MiFIR. Given that Credit Suisse is not a firm directly subject to MiFID II provisions, it is not directly obliged to comply with the best execution requirements, but endeavours to do so in order to provide the best service to its clients.

These reports should be read in conjunction with the Credit Suisse Best Execution Policy, the current version of which is available at <https://www.credit-suisse.com/mifid>.

For clients serviced by Credit Suisse legal entities or branches other than Credit Suisse AG and Credit Suisse (Switzerland) Ltd., note that there may be separate Best Execution Policies and reports with information on execution quality obtained by those entities. Please, contact your relationship manager for further information.

Until the operational integration of Neue Aargauer Bank AG (“NAB”) into CS Switzerland Ltd. is fully achieved, CS Switzerland Ltd. will not be able to include NAB clients’ orders in its Quantitative (Top 5) Report. This will only impact CS Switzerland Ltd.’s Quantitative (Top 5) Report issued in 2021 and 2022, related to the time between the effective date of the merger (Nov. 27, 2020) and the operational integration (2nd quarter of 2021). Nevertheless, the exclusion of NAB transactions does not alter the results in any of the Top 5 rankings – analytically confirmed – as the order execution patterns remain identical.

Retail Clients who fulfill two out of three criteria set up to demonstrate their knowledge and experience might also be considered Professional Clients upon their own request.
Retail Client	Retail Client means a client who is not a Professional Client.
Trading Venue	Trading Venue means any Regulated Market, MTF or OTF as defined under MiFID II.
