The digital signature is available in both E-Banking and Mobile Banking.

Initial Setup

Set up notifications in UBS E-Banking or UBS Mobile Banking to be informed via push notification, SMS or email about new agreements.

E-Banking

- 1. Choose Settings and then Notifications and Mobile Banking App.
- Under Addresses / Mobile devices, you can check if a mobile device, a mobile number or an email address is available. You can add a new mobile number or email address by choosing New.
- 3. Open Notifications and then choose Mailbox.
- 4. Choose a mobile number and/or email address for **Agreements**.
- 5. If you have a registered mobile device, you can also activate **Push notifications**.
- 6. Save your changes.

Mobile Banking

- 1. On the home screen, open your profile by choosing the **profile icon** in the top-left corner.
- 2. Choose Settings and activate Push notifications
- 3. Open Manage notifications and choose Agreements.
- 4. Turn on **Notifications for agreements** and activate the toggle for **Push notifications**.
- 5. Save your changes.
