## Integration of sustainability risk considerations in the remuneration process

Employees are assessed and rewarded for their achievement against a range of financial and non-financial goals, including risk management. Where applicable, the risk management goal will include a consideration of sustainability risk. Where sustainability risks form part of an employee's performance objectives, they are taken into account into the qualitative performance assessment, which, in turn, is one of the factors that determines an employee's total remuneration. This approach to employee's remuneration is outlined in the remuneration policy.
