As previously advised by notice on 08 March 2019, the Board of Directors of the Management Company of **CS Investment Funds 13 - Credit Suisse (Lux) Green Bond Fund** hereby inform the unitholders that, in accordance with article 1(20)(a) and the provision of Chapter 8 of the Luxembourg law of 17 December 2010 relating to undertakings for collective investments, **CS Investment Funds 13 - Credit Suisse (Lux) Green Bond Fund** (the "**Merging Subfund**") has been merged into **Credit Suisse Index Fund (Lux) - CSIF (Lux) Bond Green Bond Global Blue** (the "**Receiving Subfund**"), (the "**Merger**") as of **16 April 2019**.

The Unitholders of the Merging Subfund who have not redeemed or converted their holdings before 3 p.m. C.E.T. on 8 April 2019 have received in exchange for their contribution a number of new classes of shares in the Receiving Subfund.

This exchange has been based on the net asset values per unit of the Merging Subfund calculated on 16 April 2019 and based on the closing prices as of 15 April 2019, as follows:
