REPORTS SECOND QUARTER EARNINGS**

**New York, New York – August 15, 2023:** Credit Suisse Asset Management Income Fund, Inc. (NYSE Amex: CIK), a registered closed-end investment company, today announced earnings for the second quarter ended June 30, 2023.

Total net assets of the Fund on June 30, 2023 were \$149,399,003 as compared with \$147,349,410 on March 31, 2023 and \$146,269,016 on June 30, 2022. On June 30, 2023, the net asset value per share was \$2.84 based on 52,644,857 shares outstanding.
